The Governance Regulation is critical to coordinate national and local climate action, as an instrument to help the EU reach the 2030 climate and energy targets with planning, reporting and monitoring rules. Article 11 highlights the importance of multilevel governance to include local authorities, civil society organisations, business community, investors and other relevant stakeholders and the general public in the discussion of integrated national energy and climate plans.

A revision of the Governance is expected and recognised as necessary, but still not confirmed. EnR recommendations on the need for the revision and the regulation's content are therefore very important at this stage.

Although it is now mandatory to develop Municipal Climate Action Plans (PMAC), these issues were previously addressed in other masterplans, strategies or regulations that were not specific for climate action, but included sustainability criteria, such as adaptation concerns in masterplans, or energy efficiency measures included in budgetary or tax planning. For example, the Municipal Master Plans (PDM) and the Sustainable Energy Action Plans (SECAP) developed under the Covenant of Mayors for Climate and Energy initiative stand out. The 'other' option was selected to include the cases mentioned, i.e. where these two types of Plans exist simultaneously.

The plans developed specifically to address local climate action focus on the dimensions of mitigation, adaptation and (less often targeting specifically) energy poverty, especially since the publication of the Portuguese Climate Law. However, there are also various sectors and impact-specific plans and strategies that also include climate action issues (Sustainable Urban Mobility Plans (SUMP), Intermunicipal Adaptation Plans and Mitigation Plans such as Sustainable Energy Action Plan (SEAP)).

The 'other' option was also selected as many municipalities currently have both Comprehensive plans and Partial plans.

According to official data from the Covenant of Mayors of March 2023, in Portugal there are 178 municipalities that are signatories to the Covenant of Mayors, although most signed the commitments in the initial phase of the initiative, between 2008 and 2014. In this first phase, a 20% reduction in greenhouse gases (GHG) emissions by 2020 was proposed. In 2015, and after the merger of the Covenant of Mayors with Mayors Adapt, a new target of reducing GHG emissions by 40% by 2030 was proposed to municipalities. At this stage, only 50 Portuguese municipalities have committed to meeting the new target. In terms of the plans actually presented, of the universe of signatory municipalities, only 121 submitted plans to meet the target in 2020 and only 15 did so for the target of reducing GHG emissions by 40% by 2030.

More recently, in 2021, in line with the European Green Deal and the 'Fit for 55' package, the Covenant of Mayors proposed to municipalities to renew their commitments, intensifying actions so that it was possible to





reduce GHG emissions, not by 40%, but by 55% by 2030, as well as to include actions to combat energy poverty in their planning. To date, only 22 Portuguese municipalities have responded to this challenge, but only 5 municipalities already have plans that include measures consistent with this goal (Lisbon, Porto, São Vicente, Machico and Ribeira Brava).

Signing on appear to be dependent on the size of the municipality, as more than 91% of municipalities with a size of more than 100,000 inhabitants have become signatories to the Covenant of Mayors, as opposed to only 35% of municipalities with a population of less than 5,000 inhabitants.

With the Portuguese National Climate Law in force, an estimated 50% of municipalities have developed a Municipal Climate Action Plan (PMAC), although no monitoring structure is in place to follow up on plan development, approval, targets and performance/progress and no reporting mechanism was created yet. Such an assessment is established in the Law, expected to be defined under specifically regulation. This foreseen monitorization and assessment action will be essential in order to assess the current status of local climate action policy implementation.

As part of the national coordination of the Covenant of Mayors, surveys and direct consultations have been held with municipalities on local climate action, promoting peer-2-peer sharing between municipalities on good practices; Development of publications/articles on local climate action.

In Portugal, different actions (training, tools, financing, etc.) are also being developed under different European initiatives, although they are sometimes similar in scope. Although significant efforts are underway, there is no formal structure to monitor local climate action progress, articulate different stakeholders' action or harmonise between the different initiatives, mirroring some of the issues identified at a European level (EU Missions, Covenant of Mayors, EU Green Capital, etc, as different uncoordinated flagship initiatives, just to mention a few EU-led projects).

In addition to the activities carried out under different European initiatives, we highlight the work that has been carried out under national initiatives, such as the <u>Voluntary Carbon Market</u> and the One-Stop-shops "<u>Espaços Energia</u>", initiatives that ADENE manages and operationalises.

At national and international level, there are numerous entities, initiatives, networks and projects that aim to support local climate action. A recent report by the Committee of the Regions identified 26 EU-funded initiatives for this purpose, which can be categorised according to the functionalities and services provided: platforms, support mechanisms, access to financing, political incentive and interest representation. The report concludes that synergies need to be found between these initiatives and improve their functioning to make them more transparent and accessible to cities and regions, including by simplifying monitoring procedures, providing active and tailored support and funding opportunities for the practical implementation and monitoring of action plans, while ensuring some flexibility to meet the emerging challenges that the regional and local authorities are confronted. Collaboration needs to start at a European level, and fostered nationally, e.g., with





the promotion of national and/or regional one-stop-shop-like services/online tools for local authorities to access data, training, capacity building, shared/pooled resources, as well ad funding and financing solutions.

In Portugal, several initiatives are underway that seek to strengthen relations between municipalities and the different entities that contribute to local climate action, between the different levels of governance, and to promote collaboration between municipalities. These initiatives are mostly temporary (namely through cofinanced projects), seeking to promote multilevel dialogue, the empowerment of different actors, peer-2-peer collaboration and the development of support services and/or tools. It is essential that the broad body of work that is being developed can remain available to local and regional actors beyond the duration of each specific project, establishing a continuity that facilitates the action of all local and regional actors, regardless of their size and current capacities to design and implement planning tools. This could be achieved through the creation of Working Groups and/or a Consulting Body to support the authority(ies) tasked with progress monitoring and coordinate activities between all the relevant stakeholders. ADENE has been engaged with several organisations, namely national public authorities, city networks and ongoing projects to promote such dialogues.

In Moldova, mainstreamed plans currently represent the most prevalent approach to addressing energy and climate objectives.

Moldovan authorities incorporate climate objectives into broader national strategies, including the following:

- The National Integrated Energy and Climate Plan (NIECP) 2025-2030 and the Local Integrated Energy and Climate Plans (LIECPs), developed in alignment with the national energy framework and Moldova's EU integration commitments.
- The National Development Strategy and Environmental Strategy, both of which incorporate climaterelated considerations into wider development frameworks.
- The National Energy Efficiency Programme, aligned with Law No. 139/2018 on energy efficiency and Law No. 282/2023 on the energy performance of buildings.
- Sustainable Energy and Climate Action Plans (SECAPs), developed by select municipalities under the EU Covenant of Mayors initiative.

In Moldova, comprehensive local climate action plans (covering both adaptation and mitigation, including aspects such as energy poverty) remain rare, primarily due to limited institutional capacity and funding at the local level. Most existing initiatives take the form of partial plans, focusing on specific sectors like energy efficiency or infrastructure resilience, often developed within the framework of donor-funded projects.

While national-level programs like the National Integrated Energy and Climate Plan 2025-2030 and the National Climate Change Adaptation Programme until 2030 (NCCAP 2030) provide overarching guidance, local implementation tends to be fragmented.

In some cases, local actions fall under the "Other" category, as they are integrated into broader development or emergency response plans without a clear climate-specific framework.

In Moldova, most local climate and energy plans are developed in response to national regulations or as a condition for accessing specific funding mechanisms, which explains their higher frequency. For example, the development of local SECAPs is often linked to national and donor-supported programms.

At the same time, Moldova is actively engaged in the development and implementation of Local Integrated Energy and Climate Plans (LIECPs). According to the Moldovan Energy Efficiency Law (Law No. 139/2018), the LIECP is developed as a planning document at the local level and contributes to the implementation and achievement of the objectives set out in the National Integrated Energy and Climate Plan (PNIEC) 2025–2030. The CNED, in collaboration with the Ministry of Energy, is responsible for guiding and supporting local public authorities in the development of these plans.

The development of a LIECP template is currently ongoing and will serve as a model for local public authorities in preparing their own plans, ensuring alignment with the PNIEC 2025–2030. This initiative is supported by international partners such as the European Union, UNDP Moldova, GIZ Moldova, and others, who provide technical and financial assistance for the development of these plans at the local level.

In contrast, plans initiated independently by local public authorities remain rare, largely due to limited institutional capacity, lack of technical expertise, and financial constraints.

Similarly, while Moldova participates in international initiatives like the Covenant of Mayors, actual plan development under these frameworks is not widespread and takes place periodically, usually when external support is available.

No additional examples are known under the "Other" category at this time.

Moldova has launched several national initiatives aimed at supporting local authorities in advancing energy and climate-related actions. These include awareness campaigns, technical assistance, and guidance documents aligned with national strategies such as the PNIEC 2025-2030 and the NCCAP 2030.

Currently, CNED is in the process of initiating support actions for local public authorities in the development of Local Integrated Energy and Climate Plans (LIECPs). In this context, the development of methodological guidelines for drafting these documents has been launched. International partners are providing assistance to local public authorities in meeting the requirements set out by national legislation.

The support provided under "Other actions" is often ad-hoc and dependent on the availability of donor or project-based funding.

The National Centre for Sustainable Energy Development (CNED) is a key institution responsible for implementing national energy policies in the Republic of Moldova. In particular, CNED plays a central role in supporting and coordinating the development and implementation of Local Integrated Energy and Climate Plans (LIECPs), in accordance with the country's strategic and legal framework.

Since the adoption of the Energy Efficiency Law (Law No. 139/2018), the development of local climate and energy plans has become a legal obligation for local public administration authorities. Article 13 of the law mandates local public administration authorities to prepare LIECPs that align with national energy efficiency objectives and to update them every two years. These plans must also be submitted to CNED for consultation prior to approval, underlining CNED's advisory and oversight role.

To facilitate this process, CNED is actively engaged in the creation of a LIECP template that will serve as a model for local public administration authorities, ensuring consistency with the National Integrated Energy and Climate Plan 2025–2030. In parallel, CNED has launched the development of methodological guidelines to assist local authorities in the drafting of these plans.

In addition to its technical and consultative functions, CNED also cooperates directly with local public administration authorities by providing advisory and informational support, as well as by promoting and disseminating information related to LIECPs and international cooperation mechanisms.

These efforts are supported by several international partners, including the European Union, UNDP Moldova, and GIZ Moldova, which offer both technical and financial assistance to strengthen the capacity of local public authorities in developing and implementing local energy and climate plans.

While Moldova does not yet have a single centralized coordinating body for all transnational climate initiatives, the combined efforts of the CNED, the Ministry of Energy, the Ministry of Environment, the Municipal Development Cooperation Platform, and international partners effectively ensure alignment between local and national climate actions. These mechanisms help integrate local initiatives into broader strategic frameworks and enhance access to international support.

Promote continuous dialogue among all levels of governance (local, regional, and national) to ensure effective coordination between climate and energy plans and strategies, through the creation of national working groups, consultative councils, or other coordination platforms that bring together stakeholders to foster synergies, avoid duplication of efforts, and ensure alignment of actions across sectors and governance levels.

Promote, develop, and implement national tools that enable municipalities and local public authorities to access relevant energy and climate data, participate in training, build institutional capacity, and benefit from shared expertise and financial mechanisms, in order to foster an integrated approach to achieving climate and energy objectives at both local and national levels.

Most frequently, the LRAs that carry out climate action plans are those that are involved in the "Covenant of Mayors initiative", which takes a holistic approach to tackling climate change. This initiative is based on an integrated and participatory energy planning, in which local actors play an active role. Local authorities that sign the Covenant of Mayors initiative are committed to submitting a Sustainable Energy Action Plan (SDAE). Through SDAE, local authorities focus, primarily, on reducing energy demand within their territory as well as promoting the use of local energy sources. In SDAE, sectors such as the residential sector, the tertiary sector as well as the buildings, equipment and facilities of the Municipality, as well as the transport sector, are considered key axes of action to deal with climate change. In essence, the SDAE focuses on recording the main actions to reduce CO2 emissions, reporting planning, timetables, delegation of responsibilities and allocation of funds.

The first climate commission was established in Leeds in 2017 by a team at the University of Leeds working with Leeds City Council. Inspired by the Leeds model, new climate commissions have been established as part of the Place-Based Climate Action Network (PCAN), which commenced in January 2019. PCAN aims to produce a replicable model for other places to establish their own climate commissions, and more are coming onstream independent from, but supported by PCAN. In 2022, the UK Government established the Local Net Zero Forum. It is chaired by the Department for Energy Security and Net Zero (DESNZ) and brings together central and local government officials to collaborate on delivering net zero at the local level.

In 2023, the England Government also launched an assistance website, Net Zero Go, in collaboration with Catapult Energy Systems to support local authorities in developing "successful, locally-focused energy projects.

The Scottish Government require local authorities to prepare, publish and update a Local Heat and Energy Efficiency Strategy and Delivery Plan. The approach to developing Community-led Local Energy Plans in Scotland was developed as part of the <u>Delivering Community Benefits of Civic Energy (COBEN) project.</u> As part of the pilot, community-led local energy plans were developed in four local communities: Brae (Shetland Islands), Drumnadrochit (Inverness), Barra and Vatersay (Western Isles) and Oban (Argyll). In April 2023, the Welsh Government issued a recommendation for all 22 local authorities to prepare Local Area Energy Plans (LAEPs) for their area by 2024 funded nationally but led and developed at the local level.

Additional remarks concerning question 6: Spain's NECP (PNIEC: National Integrated Energy and Climate Plan) is designed to meet the climate objectives of the European Union, particularly those related to emissions reduction, energy transition, and energy efficiency by 2030. In its approach, the PNIEC also establishes coordination and alignment with regional and local plans and strategies, such as the Local Climate Action Plans (PACL). However, these plans are neither identical nor fully integrated in all cases. They are usually more specific and adapted to the particularities of the territory, focusing on areas such as sustainable urban transport, energy rehabilitation of buildings, and waste management.

Additional remarks concerning question 7: In Spain, local planning for climate action is not mandatory at the state level but is strongly promoted by the central government, autonomous communities, and European regulations. Its implementation depends on the commitment of municipalities, although various tools and programs encourage its development. For instance, the Climate Change and Energy Transition Law (Law 7/2021) establishes obligations primarily at the national and regional levels but acknowledges the crucial role of local entities in combating climate change. It also encourages local administrations to adopt climate action plans that include mitigation and adaptation measures.

Given Spain's governance structure, autonomous communities have competence in environmental matters and climate planning, leading most to develop regulatory frameworks or regional strategies that emphasize the need for local plans. In some cases, these strategies may require municipalities to create specific plans.

Currently, eight of Spain's seventeen autonomous communities have adopted or are in the process of adopting climate laws (Andalusia, Balearic Islands, Canary Islands, Catalonia, Navarra, Valencian Community, Galicia, and the Basque Country). All these laws require municipalities to implement local climate change and energy plans (source). Among the remaining regions, several have developed climate action strategies that, in some cases, also promote drafting local plans (e.g., the Region of Murcia's strategy includes promoting PACES development).

Within this commission, two groups—the GMIT (mitigation) and GTIA (adaptation)—meet periodically to achieve these goals.
